Message from the ESE President – Claus Löst

Dental Implant – the better tooth?



President – Claus Löst

“Implanting at the castle” was the eye-catching slogan emblazoned recently on a promotional flier from an implant company; “Get to know the world of modern implantology in an inspiring atmosphere”. The course, lasting almost 3 days, commenced with a lecture on the meaning of consumerism in dental medicine, and the target audience, can you imagine, senior undergraduate dental students.

Implant companies have significant economic power. Whilst many colleagues in Endodontology and Periodontology may be indifferent to the implant-related logos positioned by gold-sponsors on their congress bags, and others may accept them with a knowing grin, there are still others who carry a sense of betrayal, arguing for the preservation of teeth and for their scientific Societies to renounce attractive sponsorship from the ‘wrong corner’.

No matter how one views these developments, the question for me is how we can defend ourselves and our disciplines in the face of the seemingly inexhaustible financial resources of implant and associated biomaterial manufacturers? The future direction of dental medicine hangs in the balance.

Let me be clear about one thing, I am not against dental implants! There can be little doubt that they form an invaluable addition to our spectrum of restorative therapies, and it would of course be churlish to stand in the way of interested dental students who are given the opportunity to develop their soft-tissue surgical skills, and practice bone augmentation and implant placement techniques on artificial jaws in the company of enthusiastic teachers. And all that for the modest expense of an overnight stay!

But what signal is being given to these impressionable dental students by the whole event, and in such unique and desirable ambiance? May we assume that the sponsoring companies will place tooth preservation at the top of their course agendas, or will they see ‘compromised’ teeth as dispensable items for replacement?

Suspicion would appear to be justified. Case reports in scientific journals that are often sponsored directly or through advertising revenues appear with shocking regularity to show the implant replacement of teeth that many would consider restorable. Others appear to avoid the issue by cutting out the assessment stage and starting their accounts with ‘emptied

alveoli’. Yet others will simply state that the tooth or teeth involved were non-sustainable; declarations that can leave experienced practitioners scratching their heads in disbelief – the clinical and radiographic appearances didn’t seem that bad! I turn at this point to Jan Lindhe, a world authority in Periodontology, who is believed to have coined the phrase: “Implants should replace missing teeth – not teeth”.

Such statements may be balm to the souls of conservative dentists, but judgements on the prognosis of teeth are always subjective. We do not currently have an objective, consistent means of defining those teeth that are truly beyond restoration; perhaps we never will. But it is unwise to throw away the well-honed skills of the conservative dentist and opt for the wholesale loss and replacement of any ‘compromised’ teeth, just to be on the safe-side. There has never been greater need for the skills and insights of responsible, academically trained dentists; those able to balance deep knowledge of the scientific literature, with experience and holistic decision-making. I strongly doubt that the high-profile marketing strategies of implant manufacturers will promote this approach in our dental students.

Lastly, the loss of ‘compromised’ teeth and their replacement with implants has an ethical dimension. I wonder if the dental community could make a step in the right direction by rejecting all verbal and written case reports that do not fully expose the presenting findings and the decision-making process for tooth preservation or replacement with implants. In this way, every speaker and author would be mindful of the need to defend their decision-making in a rigorous manner. Are we on the road to the loss of our conservative skills, to the loss of teeth that could realistically be saved, and the unthinking replacement of teeth with implants? We need to open this academic discussion and think carefully about our decision-making. The best interests of our patients and our profession are at stake. In concluding this Presidential statement, I would like to extend my thanks to the ESE Public Relations Committee, under the Chairmanship of Carsten Appel, for initiating a campaign to inform the public, patients and dentists about the benefits of tooth preservation. What a strange world we live in, where the preservation of teeth needs to be the subject of an advertising campaign!

ESE Executive Committee, Rome, 13th September 2011

- Recognition of endodontics as a clinical speciality throughout Europe

As the ESE evolves into the next stage of its development, changes are needed to the structure and manpower of its Executive Board and committee structure. Key changes were approved by the Rome 2011 General Assembly and include:

- The need for an Administrator to coordinate and oversee the work of the Executive Board and its committees.
- The withdrawal of the Editor position, with responsibilities of the Editor being integrated into the Research Committee.
- The addition of Research and Education & Scholarship Committee Chairs to the Executive Board as ex officio members, with equal voting rights.

It was reported that Ms Susan Bryant would adopt the role of ESE Administrator, with John Whitworth re-joining the Board as Education and Scholarship Committee Chair.

Research News

ESE Research Grant winners

The European Society of Endodontology remains just that – a society driven by the interests of scientific and scholarly advance. One expression of this is the award of an annual research grant, with successful applicants announced in November.

The 2011 Grant

Faced with strong competition from no less than 11 applicants, the ESE Research Committee concluded it's deliberations in November, awarding the 2011 Research Grant to Prof. Dr Kerstin M. Galler from the University of Regensburg, Germany

Title: Release of Growth Factors from dentine and incorporation into a hydrogel scaffold for regenerative endodontics

Award: 18,000 Euros

Dr. Galler is an Assistant Professor in the Department of Restorative Dentistry and Periodontology at the University of Regensburg, Germany. After gaining her DDS degree from the Ludwig-Maximilians-University in Munich in 2000, she worked in private practice in Germany for two years. Subsequently, she started her first research project at the University of Regensburg, then transferred to the University of Texas Health Science Center in Houston to complete post-doctoral training; she was awarded a PhD in Bioengineering from Rice University in Houston in 2009. Recently, she finished her "Habilitation" with Prof. Gottfried Schmalz at the University of Regensburg. Dr. Galler's time is divided between clinical work

(primarily endodontics), teaching and research. Her current research interest is focused on the development of future treatment strategies incorporating scaffolds with biological dentine conditioning and dental stem cells for use in dental pulp tissue engineering and regenerative endodontics.

Abstract

Recent advances in stem cell biology and dental pulp tissue engineering as well as clinical reports of regenerative procedures to sustain tooth vitality might be the prelude of a paradigm shift in endodontics and lead to the establishment of treatment strategies enabling the regeneration of dental pulp. Whereas implantation of autologous stem cells is a promising strategy, it is hampered by issues of cell harvesting and expansion as well as high cost. Alternatively, cell-free approaches could be considered, which involve the recruitment, migration, proliferation and differentiation of resident stem cells. The conditions for such a regenerative procedure might be optimized by the use of a bioactive scaffold material, which is placed into the root canal, and furthermore by taking advantage of growth factors entrapped in the dentine matrix. Modified protocols for root canal preparation, irrigation and filling will be required in order to provide an environment that is conducive for stem cell recruitment and new tissue formation. In the proposed project, a protocol for root canal irrigation should be established, which will allow for the release of growth factors from the dentine matrix. Their short half-life could be prolonged by incorporation into a matrix capable of binding and cell-mediated release of these growth factors. A previously developed bioactive peptide-based hydrogel can bind and release growth factors via the glycosaminoglycan heparin. By optimizing conditions for growth factor release and enabling their immobilization, chemotactic migration and subsequent differentiation of stem cells might be triggered. This work could contribute to the development of a treatment strategy to engineer dental pulp which does not require the application of exogenous stem cells or growth factors and might thus be readily applicable in regenerative endodontics.

Title: How to disrupt biofilm matrix

Award: 10,000 Euros

Affiliation: Academic Centre for Dentistry (ACTA), Amsterdam, The Netherlands

Abstract

In endodontics, we are well aware that in infected root canals, micro-organisms live in a biofilm configuration. This makes them less susceptible to antimicrobials. Increased resistance is partly due to the change in genetic make-up. But also, biofilms consist for 95- 99% of extracellular polysaccharides (EPS), which are produced by the micro-organisms that live within this substance. This substantial part of the biofilm is often overlooked in studies that investigate the efficacy of antimicrobial compounds.

Literature on the composition of EPS from areas of research other than Endodontology can help us to get a better understanding of endodontic biofilms. New insights may lead to the development of a more efficacious root canal disinfection protocol.

European Society of Endodontology Congress, Rome 2011

Rome was a perfect background for the 15th Biennial Congress of the European Society of Endodontology (ESE) which took place in the Monte Mario Hotel Cavalieri from the 14th to 17th September 2011 (Fig 1).

The whole event was brilliantly co-ordinated by Dr Marco Martignoni, President of the Italian Society of Endodontology (SIE) (Fig 2), supported by Congress Secretary Vittorio Franco

The event was another record-breaker with more than 2000 attendees from 70 countries, including general dentists, specialists and postgraduate students. Its ranks were further graced by a number of prestigious international delegations including those of the American Association of Endodontists (AAE) and the

International Federation of Endodontic Associations (IFEA), by the chairman of the next APEC Congress (Asian Pacific Endodontic Confederation) and the President of the Pan-Arab Endodontic Conference 2012. The organisers and delegates were grateful for the commercial support of a number of companies, including 11 platinum, silver and bronze sponsors, and a total of 26 exhibitors with dedicated booths (Fig 4).

Making an early start, the ESE Executive Board addressed a full business agenda and received up-to-the-minute news of the Congress throughout Tuesday 13th. In keeping with tradition,

Wednesday 14th played host to the ESE General Assembly, with country representatives gathering from all corners of Europe (Fig 5). Key business included a series of bids to host the 2015 Congress. After four engaging presentations, the

voting was sure to be tight, with Spain and Barcelona eventually emerging as the winner.

In parallel sessions, 3 pre-Congress hands-on workshops focused on practical aspects of treatment and provided state-of-the-art experiences with the latest tools and canal shaping technologies.

The day rounded-off with a late afternoon welcome cocktail party in the sumptuous surroundings of the conference hotel (Fig 6).

Thursday morning saw the grand opening ceremony, with a specially commissioned and heart-warming video documenting the history of the ESE, landmark biennial congresses and some of the greats in Italian endodontics. There were heart-felt welcomes from a panel of dignitaries including the Rector of the University of Rome "La Sapienza" Prof. Luigi Frati, the President of the Academic Board and Director of the Dental Clinic of the University of Rome "La Sapienza" Prof. Antonella Polimeni, the Director of the Dental Clinic of the University of Rome "Tor Vergata" Prof. Alberto Barlattani and the President of the Degree Course in Dentistry of the University of Rome "La Cattolica" Prof. Massimo Cordaro. The Minister of Health Ferruccio Fazio was sadly unable to attend, but was represented by Prof. Enrico Gherlone, Full Professor at the San Raffaele Hospital in Milan and Delegate for the Dental Sector of the "Programming Commission" of the Ministry of Labour, Health and Social Policy and Member of the Board of Health. How could such a high-profile Italian opening be followed but by a solo tenor, accompanied on the piano through classics including the

the start of the scientific programme? They were duly rewarded on both counts.

"Not Only Roots", was the theme of the Congress which continued in 5 conference rooms, with high-level presentations on topics including cleaning and disinfection, mechanisms and management of inflammatory pain, methodological issues in endodontic research, dental pulp tissue regeneration, techniques for shaping root canals, anatomic and diagnostic challenges, endodontic surgery, root canal obturation techniques, orthograde endodontics, endodontic retreatment or implants and post-endodontic reconstruction.

Among the most prominent international speakers were Markus Haapasalo, Roeland de Moor, Luc van der Sluis, Gunnar Bergenholtz, Lars Bjørndal, Carsten Appel, Gilberto Debelian, Jean Yves Cochet, Bertrand Khayat, Paul Lambrechts, Michael Naumann, well known Americans including Ben Johnson, Cliff Ruddle, Steve Buchanan, Jim Gutmann and Ken Hargreaves, and not to mention home-grown Italians including Francesco Mannocci, Giuseppe Cantatore, Elio Berutti, Gianluca Gambarini, Fabio Gorni, Augusto Malentacca, Arnaldo Castellucci and Marco Ferrari.

One of the true highlights was a symposium on 'Dental pulp tissue regeneration: visions and challenges', hosted by, and in honour of the Society's most recent and cherished Honorary member,

Gunnar Bergenholtz. The symposium opened the minds of delegates to the clinical potential and highlighted some of the scientific challenges in realising Endodontology as a discipline at the cutting edge of regenerative therapy (Fig 8).

In separate sessions 105 national and international speakers presented on freely chosen topics, while others enriched the meeting further with 139 moderated research posters on a wide range of topics (Fig 9) and 163 clinical posters.

Official business included the award of the Wladimir Adlivankine Award to Dan-Krister Rechenberg (Fig 12) for his work on "Potential systematic error in laboratory experiments on microbial leakage through filled root canals: an experimental study", supported by Matt Zehnder at the University of Zurich. Following hot on his heels was Stephane Simon from the University of Paris

Croatian Endodontic Society (CES)

The Croatian Endodontic Society held its 11th Annual Congress on 19-20 March 2010 in cooperation with the Department of Endodontics at the School of Dental Medicine in Zagreb, Croatia. Participation was truly international and the lecture topics ranged across a number of dental disciplines, all contributing to a high quality and extremely well attended Congress.

As a flavour of the programme, lecture topics embraced endodontics, preventive dentistry, post-endodontic restorative treatment and patients at risk in the dental office. Hands-on courses on rotary endodontics and thermoplasticised obturation techniques, fabrication of direct composite veneers on anterior teeth, minimally invasive approaches in dentistry, and preparations for partial and complete coverage restorations were held on the first and second days of the Congress. Twenty posters were also presented during the Congress by members of the CES.

Following in the tradition of the Society, several hands-on courses on rotary endodontics (ProTaper) and thermoplasticised obturation techniques (Thermafil) were organized during 2010 in cooperation with Maillefer and Medica.

In September, an International Croatian-Austrian Meeting was held in Opatija, Croatia. The meeting was organized by Professor Ivica Anic from School of Dental Medicine in Zagreb.

At the beginning of the meeting, all of the combined projects that had been worked out during the last two years were presented by collaborators from the School of Dental Medicine in Zagreb and Rijeka and Graz University. Scientific and clinical research based on endodontics, restorative and preventive dentistry was also presented. All presentations were followed by constructive discussion. We also established future cooperation in scientific work.

Czech Endodontic Society

The Czech Society of Endodontology has entered its second election period. On March 5th 2011, members of the Czech Society of Endodontology (CES) met as traditionally at the Hotel Pavilon in Ricany near Prague for their 9th workshop. The main items of business were to review the balance of

CES activities over past 4 years and to elect a new committee.

The CES chairman, Mr Ludek Perinka reviewed and critically appraised Society activities, noting considerable success in engaging dental practitioners with a deep interest in Endodontology, incorporating the CES within the European Society of Endodontology (ESE) and bringing the CES and its activities to the attention of international experts.

Regular workshops of the Society where members can present their case studies, in addition to well-attended annual conferences give clear testament to the effective work of the CES. Some targets have not yet been fully attained, particularly improvements in the quality of postgraduate training in Endodontology and issues around the initiation of standards in Endodontology.

The new committee election was conducted by secret voting in compliance with the Society charter, and the number of members was increased from 5 to 7. Elected members of the new committee were: Perinka, Roubalíková, Netolický, Ságlová, Horák, Dancík, Svetlík. Mr Ludek Perinka remains the CES chairman, Mrs Lenka Roubalíková the scientific secretary, and Mr Jan Netolický the economist. In future, the CES will make efforts to perform its obligations in accordance with the charter, particularly in the spheres of postgraduate studies and standards/improvements in the quality of Endodontic care.

The Society also looks forward to working with the ESE in developing new initiatives and possibilities. It is safe to say that the committee has a unanimous and indomitable will to continue the activities it has already started, and looks forward to the ongoing success of the Society.

The Czech Society of Endodontology arranges scientific workshops twice a year and holds an annual conference. The most recent workshop of the CES was held on June 3rd and 4th 2011 in Trebon, Czech Republic. Several members of the CES took part and delegates were mindful of the approaching ESE Biennial Congress to be held from September 14th to 17th 2011 in Rome.

Activities for 2011 culminated in the third annual conference of the CES on October 1st 2011 at the Hotel Pyramida, Prague, Czech Republic. Everybody enjoyed valuable specialized lectures given by eminent personalities in Endodontology, both from the Czech Republic and from Slovakia. The endodontic-conference year was pleasantly closed by an 'exit conference' in Patince, Slovakia on November 25th to 27th, 2011.

Annual Convention 2010 of the Deutsche Gesellschaft für Endodontie in Berlin

Pre-Congress Workshops

This year, the capital city attracted almost 400 committed participants to an outstanding programme.

The first colleagues arrived at the Pullman Hotel "Schweizer Hof" in Berlin City on Thursday at noon, ready for hands-on workshops conducted on the afternoon before the main convention.

Only "early birds" were lucky enough to claim one of the limited number of seats available. Demand was understandably great for presentations on the various systems and technologies on show; exciting concepts and technologies with the potential to enforce a paradigm shift in our endodontic work.

The hands-on workshops which were run by experts, partly by the presenters, partly by representatives of the industry, provided the opportunity to try out file systems at very well equipped workstations and to discover the possibilities and perils of the respective concepts.

Main Convention Friday

In the morning of the first day, Dr. Carsten Appel/ Niederkassel, the President, and Priv.-Doz.Dr. Christian Gernhardt / Halle (Saale), member of the Board, welcomed all participants in the large Convention Hall of the hotel. After a few organisational notes, the first speaker was introduced, Prof. Gustavo De-Deus from Rio de Janeiro.

The topic of his speech was 'leakage', i.e. the occurrence of bacterial passage-ways in the area of the root filling. Prof. De-Deus was able to deliver tough scientific facts the Brazilian way. In the breaks, the participants could visit the comprehensive dental exhibition. Many important industrial representatives were there with their array of endodontic products.

In the afternoon, Prof.Dr.Dr. Rudolf Reich, an Oral Surgeon, addressed the audience. His speech dealt with the possible complications after endodontic treatments and how they are managed.

The speaker that followed was Prof. Zvi Metzger from Tel Aviv. He introduced the Self Adjusting File (SAF) system. The system is able, in one step, to clean and disinfect the root canal system requiring a single instrument only. Most interesting was his evidence to show how well the SAF

manages oval canal structures compared to traditional methods, and how the anatomy is respected.

The second working concept was shared by Prof. Ghassan Yared who has dealt for many years with the reciprocal movement of root canal instruments. In his final speech on Friday night, he encouraged thought on implementing new ways of approaching root canal treatment, notably on the effectiveness of working instruments and their resilience to fracture.

Evening Event in the Water Works

The facilitators of this year's Annual Convention found the ultimate place for the essential evening get-together. In the breath-taking environment of the historic water works of Berlin in Wilmersdorf, guests enjoyed a relaxed evening among the old pumping machines in industrial design.

Main Convention on Saturday

Astoundingly, despite the preceding long night out, the Convention Hall was already full when Prof. Kenneth Hargreaves from San Antonio entered the stage.

Many know this speaker as the editor of the Journal of Endodontics and Editor of the standard textbook Pathways of the Pulp. During several enthralling hours, he presented an exceptional summary of regenerative endodontics, ranging from the currently applied and already very well examined method of revascularisation/ root generation, to an insight into research on stem cells and the implications of growth factors in endodontic therapy. His overview was comprehensive and was followed by a question and answer session in which he calmly and explicitly addressed all of the questions of those wanting clarification or wanting to take things more deeply. An impressive speaker whose engagement for this Convention deserves particular thanks from the organising team!

In the afternoon, a particular team excelled with a thrilling presentation on postendodontic care, an important and complex part of our practical work that requires a periodic update.

Together, Dr. Clemens Bargholz from Hamburg and Dr. Uwe Blunck from Berlin were able to perfectly demonstrate how individual steps of treatment should be performed according to current best knowledge in adhesive technology.

The Annual Convention of the DG Endo allows only one conclusion: With perfect organisation and an excellent choice of top-class speakers, attendance at the Berlin event was definitely very worthwhile! For all of those who keep questioning their actions and aim at getting better and better, it was an absolute highlight.

Lithuanian Society of Endodontology

The Lithuanian Society of Endodontology was established by a small group of 13 Endodontists and Odontologists in November 1993, becoming the first Professional Dental Society in Lithuania. The constitutive meeting took place in Vilnius, capital of the Republic of Lithuania. Thanks are due to the commitment and hard work of the founder members - prof. Vytaute Peculiene, assoc. prof. Rasmute Maneliene and dr. Bronius Sidaravicius.

The main reasons for establishing the Lithuanian Society of Endodontology were to promote Endodontology within the profession, to establish an active partnership with other dental societies, improve the representation and profile of Endodontology within Lithuanian dental schools and to facilitate expert communication and discussion among dentists.

At the present time, the Society has about 80 members. The members of Society's executive board currently are: assoc. prof. Saulius Drukteinis (President), prof. Vytaute Peculiene, dr. Greta Lodiene and dr. Bronius Sidaravicius (Secretary).

Last year, the General meeting of members decided to apply for full membership of the ESE. Our application was successful and we were accepted as a full member at the General Assembly of the ESE in Lisbon on 23rd October, 2010.

The meeting started with a short slideshow of images reflecting the history of the LSE. After a short complimentary speech, the former President of the LSE, prof. Vytaute Peculiene was awarded Honorary Life Membership of the LES in recognition of her outstanding contribution to Endodontology, and to a wealth of scientific, academic and social activity (Figure 2). Prof. Vytaute Peculiene led the foundation and development of the LSE for many years. Currently she is the dean and professor at the Institute of Odontology, Faculty of Medicine, Vilnius University and member of Society's Executive Board.

The scientific programme was started by Prof. Vytaute Peculiene. She gave an excellent presentation, describing the risk factors influencing vertical root fractures of endodontically

treated teeth and the possibilities to prevent them in clinical practice. A lecture about root resorptions during orthodontic treatment was given by Assoc. Prof. S. Drukteinis and Dr. L. Linkeviciene. They analysed the types and mechanisms of root resorptions, the risk factors and strategies of prevention and treatment.

The invited speaker, Dr. Asgeir Sigurdsson from Iceland, introduced current concepts in diagnosis, treatment and prevention of dental traumas, and the management of late complications during his 3hr

presentation (Figure 3). The step by step clinical use of MTA was then introduced by Dr. G. Lodiene. The final lecture was given by Dr. K. Bušauskas and Dr. R. Veberiene. They presented difficult and unusual endodontic cases and discussed possible treatment options.

The first day of the meeting ended with a get-together party in 'Ben's bar' in the venue hotel. It was a great chance for all speakers, guests and participants to discuss the topics of the lectures and enjoy the company of good friends.

Dr. D. Ivanauskaitė started the second day of the conference with her lecture about the possibilities of cone beam tomography in diagnosis and differentiation of endodontic diseases. The problems arising during post removal were analysed by Dr. Ž. Grabliauskiene.

The invited speakers Dr. Nicola M. Grande and Dr. Gianluca Plotino from Italy gave a 3 hr lecture entitled "The future of root canal cleaning and shaping" (Figure 4). They discussed the current literature on root canal anatomy, conventional and new instrumentation techniques, and introduced reciprocating NiTi files, their advantages and disadvantages. Great attention was given in the lecture to intracanal medicaments and different irrigation protocols.

Meeting of the Post-Graduate Endodontology programmes of the Low Countries

The Academic Centre for Dentistry Amsterdam (ACTA) hosted the 2nd meeting of the postgraduate endodontic programmes of the Low Countries in November 2010. Postgraduate students and staff from the Catholic University in Leuven, the University of Gent in Belgium and ACTA, the Netherlands participated in a 2 day programme that included lectures from programme directors or their representatives about the history and structure of the postgraduate endodontology programme at their schools. A scientific programme was also presented by post-graduate students from the three universities. A large number of the presentations dealt with new imaging techniques and especially the endodontic applications of Cone Beam CT.

In addition to the educational programme, participants enjoyed a festive social event sponsored by Dentsply. The meeting was a big success and all participants promised to see each other at the next meeting, scheduled to be in 2013 in Leuven, Belgium.

A competition between all presentations resulted in a win for Veerle Gunst, a post-graduate from the Catholic University of Leuven in Belgium who presented interesting cases of cervical root resorption in individuals playing wind-instruments. The abstract of her exceptional presentation is enclosed below.

Playing wind-instruments as a possible etiologic cofactor in external cervical root resorption: two case reports

Veerle Gunst, Catholic University of Leuven, Belgium

Aim To present two cases of external cervical resorption (ECR) on maxillary incisors, in which the primary aetiologic factor is suggested to be pressure trauma by frequently playing wind instruments.

Summary The exact aetiological spectrum of ECR is still poorly understood. For resorption to occur, a defect in the cementum layer (trigger) is a likely prerequisite. While the mechanism for continuation (stimulus) is still unclear, knowledge of potential predisposing factors is important in assessing patients at risk. Pressure generated by playing wind instruments could present an aetiological factor in ECR because it affects the cervical region of the root surface. The cases that are presented may confirm this hypothesis and the extent of resorption defects is shown by cone-beam CT and micro-focus CT imaging techniques.

Key learning points:

- The repetitive forces generated by playing wind instruments could be compared to excessive and longstanding orthodontic forces and therefore may initiate and stimulate ECR.
- Music teachers as well as general dental practitioners should be aware of the potential impact of playing wind instruments on the orofacial structures.
- If possible, a protective mouth guard should be fabricated and used while practicing.
- Cone-beam CT analysis is useful for the clinical diagnosis and treatment planning of ECR.
- Micro-focus CT analysis does reveal the extent and complexity of an ECR defect ex vivo.

A window on National Endodontic Committee business:

Pooling strengths in Germany

Following this motto, the Deutsche Gesellschaft für Zahnerhaltung (DGZ; German Society for Conservative Dentistry) and the Deutsche Gesellschaft für Endodontie (DGEEndo; German Society for Endodontics) have launched a new chapter in the history of Endodontology and Conservative Dentistry in Germany. For two years the boards have increased their contact and held joint conferences. This was the beginning of a productive and, most of all, trustful co-operation.

The greatest restructuring occurred within the DGZ (German Society for Conservative Dentistry). This has become the 'parent' organisation for all Dental Conservation specialist societies:

- Restorative Dentistry
- Endodontology & Dental Traumatology
- Preventative Dental Medicine

The respective strengths of the individual societies can now be pooled and jointly represent the field of Dental Conservation.

Endodontology will be represented within DGZ by the newly named 'Deutsche Gesellschaft für Endodontologie und zahnärztliche Traumatologie' (DGET). All previous activities of the DGEEndo will be continued by the existing board and previous activities of the Arbeitsgemeinschaft für Endodontologie und Traumatologie (AGET; Work Group for Endodontology and Traumatology /DGZ) will be incorporated within the DGET.

The goals of the revised structures are:

- Uniform representation of Endodontology in Germany;
- Joint representation also in relation to and together with the professional and industrial politicians;
- Common criteria for the specialist in Endodontology;
- Uniform representation at the European level (ESE);
- Intensive close collaboration between universities and dental practice;
- Use of joint resources for conferences, curricula, training events, etc;
- Avoidance of competing events;
- Joint preparation of scientific papers.

The framework has now been established - but there is a lot of work still to be done. We hope in this respect to receive the encouragement and the support of everyone, and are sure that we will achieve even more together in the future!

Retirement of Min Kai Wu



On September 29, 2011 Dr Min-Kai Wu retired from his active academic career at the department of Endodontology of the Academic Centre for Dentistry Amsterdam (ACTA) with a final lecture and a reception that was attended by many colleagues and students.

Dr Wu first came to Amsterdam in 1988 as a visiting scholar from China for a period of 6 months but returned to ACTA in 1989 during the ESE congress in Amsterdam and stayed thereafter, first as a guest scientist and later on as a PhD student to finish in 1993 his thesis: "In vitro determination of leakage in endodontic research". Part of this thesis was his still very frequently cited paper; "Endodontic leakage studies reconsidered".

After completing his thesis Dr Wu continued to work at ACTA focusing on various aspects of endodontic research and educating postgraduate students by teaching them a critical approach towards dental research, stimulating them to analyze the literature and assess existing evidence. He was the scientific mentor of several PhD students and guest researchers.

Dr Wu published about 90 articles in SCI indexed journals and was key note speaker at many major endodontic congresses. His thought provoking papers and lectures have made him a special person in the endodontic arena. He is a visiting professor at the University of Peking in Beijing, China, and served for several years as an associate editor of the International Endodontic Journal. Hopefully he can still function as a freelance scientist after his retirement, and guide more young researchers to become mature independent scientists that can take over what he has sown and planted.

We are very grateful for what he has done for the science of endodontics.

In memory of Wladimir Adlivankine

Tribute to Dr.med.dent. Wladimir Adlivankine



Dr.med.dent Wladimir Adlivankine was a founding member and honorary member of the Swiss Society for Endodontology (SSE). Wladimir was a character who endowed those that knew him through his fascinating life with only the best memories.

He was born in 1926 in Alexandria, Egypt to parents, originally from Russia. This explains his lingual acrobatics as he juggled 8 languages - Russian, German, French, English, Italian, Portuguese, Spanish and Arabic.

His ability to master all these different languages was closely linked to his readiness and pleasure to meet other people. He was of an immense culture, extremely well read, a reliable and loyal friend who paid special attention to the personal angles associated with friendly human relationships. This facet of his personality has deeply impacted every dental society to which he contributed.

Before becoming a dentist he studied at the faculty of Medicine in Lausanne, guided by parental preference. However unconvinced by rote learning and with youthful abandon, he changed his life and travelled to Brazil. Here he became, for three years, the director of a factory making gum based obturators for medical containers - perhaps a first inkling of his future chosen speciality.

Realizing that this kind of occupation would not fulfil his life objectives he found himself at another crossroads. At this point he decided to go up to Bern to read dentistry. Several years later he dissertated with a doctoral thesis supervised by Professor André Schroeder, published in Bern and Heidelberg. The topic was, "Electrosurgery in Endodontics", an exciting and promising area of research at that time. Sadly, some monkeys paid with their lives during the experimentation.

During his programme in Bern, he met and subsequently worked with the endodontic pioneer, Peter Guldener. Between the two men, a true friendship was born and, inevitably as a spin-off from this, his involvement in Endodontology began in earnest. As a matter of course Wladimir became the treasurer of the European Society of Endodontology (ESE) and thanks to his financial skills, he was a money manager without equal, he nurtured the funds of the ESE and they grew favourably. This was not his first try as treasurer since during his dental studies, he had already been the treasurer of the International Association of Dental Students.

In 1977 he opened his own dental practice, whilst continuing his international activities. In 1991, Peter Guldener, Michel Cergneux, Wladimir Adlivankine and Ram Nair founded the Swiss Society for Endodontology (SSE). Inevitably he was named treasurer of the SSE and built, as he did for the ESE, some good financial basis.

In recognition for his work for the ESE the "Wladimir Adlivankine Research Prize" was born and is awarded by the ESE Research Committee for the encouragement of research related to Endodontology.

He also became an honorary member of the SSE, and in the annual SSE conference in January, stands in the calendar, as a touchstone of his brilliant work.

It seems appropriate, that at this time of year, Autumn 2011, there was the ESE Conference in Rome. And perhaps with a nod to ESE history we do not forget those, including Wladimir, who have helped us get to where we are now.

All the dental community misses him and we address our warmest sympathy to Barbara his wife, who stays very close to the Swiss endodontic community, giving a hand every time she can.
